

## RULES FOR MONTHLY HANDICAP CONTESTS

- Open to all members of the Delaware Park Player's Club.
- Participants must be at least 21 years old to join and present valid identification.
- Membership is free.
- No employees of Delaware Park or their immediate families are eligible to participate.
- Prizes are non-transferable.
- All winners are responsible for all local, state and federal taxes that correspond with prizes won.
- Delaware Park is not responsible for lost, damaged or stolen account cards.
- Delaware Park reserves the right to change or cancel this promotion without notice.

### **To Enter**

1. Participants must enter in person at the Race Book main teller window and show their Player's Club card and proper ID.
2. Participants must pay a \$40 entry fee (cash or comp).
3. Participant must then purchase a \$100 betting card (comp MAY NOT be used for the betting card).
4. **Maximum two entries per participant**
5. Entries will close no earlier than the Contest's first race.

### **To Win**

1. Participants must wager on Aqueduct, Gulfstream, Keeneland, Tampa Bay, Pimlico and Philadelphia Park.
2. Only win, place and/or show wagers are acceptable.
3. Participants must wager on a Minimum of 10 races (NO Maximum).
4. \$10 Minimum bet per race (NO Maximum)
5. The participant with the highest total after the last race will be the winner.
6. In the event of a tie for 1<sup>st</sup> place, the player placing the most wagers will be declared the winner.
7. Second, third and fourth place finishers will win the appropriate prize money for their totals.
8. In the event of a tie for 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> place the prizes for those places will be combined and split.
9. Owners, Trainers and Jockey Agents may not wager on any races in which they have a betting interest.

### **Prizes**

- 100% of the entry fees will be awarded as prizes for each contest.
- Distribution will be as follows: 1<sup>st</sup> Place 50% - 2<sup>nd</sup> Place 25% - 3<sup>rd</sup> Place 15% - 4<sup>th</sup> Place 10%.
